Presentation purpose:

The objectives of this presentation are to increase awareness of the incidence of Opioid Use Disorder and the benefits of initiation of buprenorphine in the inpatient setting for patients suffering from Opioid Use Disorder in addition to a primary diagnosis for which they are hospitalized. Additional areas that will be discussed are patient education, stigma reduction and buprenorphine dosing in the initiation of the "B Team" concept.

Learning objectives:

- Describe the necessary components to establishing a Buprenorphine service that is sustainable within the ministry and community.
- Identify those patients with opioid use disorder and formulate a plan to treat withdrawal and to initiate buprenorphine.
- Recognize common concerns and opportunities for growth while treating patients for OUD.
