# Neuropharmacology in the ICU

## Presentation purpose:

This will be a lecture on pharmacological management of various neurological disorders in the neuro-intensive care unit, including, but not limited to, hyperosmolar therapy, managing increased ICP, status epilepticus, and sedatives.

## Learning objectives:

- Compare and contrast the use of mannitol and hypertonic saline for the management of intracranial hypertension.
- Provide a hyperosmolar therapy recommendation including dosing based on patient specific factors.
- Recommend an antihypertensive regimen for the acute management of blood pressure following an intracerebral hemorrhage.
- Develop an anticoagulation reversal strategy based on a patient's specific anticoagulant.
- Recall indications, contraindications, dosing, and monitoring for tenecteplase for acute ischemic stroke.
- Recall common emergent initial therapy and urgent control medications
