Presentation purpose:

As part of the interdisciplinary care team, pharmacy staff and service is often requested urgently to meet the needs of trauma patients without having much information of patient or their illness and injury process. The speaker will review how to identify and apply best practice interventions to optimize outcomes for regarding pharmacological therapy for trauma patients presenting through the Emergency Department.
