Presentation purpose:

Migraine headache is a common, debilitating disorder. Since 2018, there have been at least seven new FDA-approved medications which includes three novel classes of medication as well as four neuro-modulation devices. This activity will cover three new classes of FDA approved migraine pharmacological therapies as well multiple FDA approved neuro-modulation devices for headache therapy.

- To understand the role CGRP plays in headache disorders
- To explore the extended data for CGRP modulating monoclonal antibodies (mAbs)
- to introduce novel classes of migraine medications
